Expiry Date: 50 years from the date of signature by the Grantee.

Rules and Regulations:

The Rules and Regulations of the Granter relating to the operation and management of the Burial Ground, a print of which is attached to this Certificate.

1. In exchange for the Price, the Granter hereby grants to the Grantee the exclusive right of burial in the Plot for the Term.
  
2. The Grantee, by his or her signature hereto
  - (a) consents to the Granter opening the Plot for the purpose of his or her interment
  - (b) agrees to indemnify the Granter in respect of any claim, action, demand or liability arising directly or indirectly from the granting of consent in (a) above
  - (c) agrees that the Price is payable in two instalments, £850 in exchange for this Certificate and the remaining sum for interment upon instructions being given to the Granter to open the Plot
  - (d) acknowledges to have read, understood and accepted the Rules and Regulations
  - (e) accepts that, if not taken up by the Expiry Date, the right hereby granted shall be lost without any liability on the part of the Granter
  - (f) accepts that the right hereby granted is not assignable
  - (g) confirms that he or she has taken independent legal advice or has declined the opportunity to do so prior to signing this Certificate.
